(a) Vehicles: Applicants for a Ground Transportation Vehicles for Hire Company Permit must own or lease no less than 20 vehicles *unless previously permitted to operate as a taxicab company in 2015.* {(Sec 22-243(a)}, Vehicles to be operated under this permit may not have a vehicle age greater than seven years as of January 1, 2017 {(Sec 22-236(8)} and are subject to inspection by the Airport's Ground Transportation Division.

Complete the attached Driver/Vehicle Fleet Log listing the CPNC number of each vehicle for hire that will be operating at the airport as well as the year, make, model, license tag number, expiration date and transponder (AVI tag number).

- (b) Employee/Independent Contractor: As a condition for obtaining and maintaining a ground transportation vehicle-for-hire company permit, taxicab company is responsible for ensuring that all drivers have secured a for-hire license endorsement issued by the Georgia Department of Driver Services or have secured, or intend to secure, a private background check in lieu of the for-hire endorsement. If any driver operating under your permit has secured, or intends to secure, a private background check, the company is required to pay an airport terminal security fee of \$2.35 per trip for every trip originating from the Airport regardless if the particular driver has a for hire endorsement. {(Sec 22-202)}. Please complete the required information for each driver on the Driver/Vehicle Fleet Log (Drivers' Names, Drivers' License numbers and License expiration date and Insurance information for each listed driver.
- 4. In order to secure a ground transportation vehicle for-hire company permit under this division, the taxicab company applicant must provide information showing its qualifications on a form provided by the city. The applicant, or the applicant's local agent must be:
 - (a) At least 18 years of age.
 - (b) A citizen of the United States or an alien admitted for permanent residence or otherwise granted employment authorization by the United States Immigration and Naturalization Service.
 - (c) A resident, for at least one year immediately preceding the date of application, of the state.

- 1) W-9 Form for the business
- 2) E-Verify (S.A.V.E or Private Employer's Affidavit)
- 3) Copy of 2017 Department of Public Safety For Hire (company) Service License.
- 4) <u>Commercial General Liability Insurance (as outlined above).</u>
- 5) Signed Ground Transportation Vehicle for Hire Company Permit.
- 6) Non-refundable application fee of \$20, payable to the "City of Atlanta"
- 7) Permit Fee payable to the "City of Atlanta" in accordance with the Number of Vehicles Applicant to Operate.

By my signature below, I certify that I understand that my company is prohibited from operating its transportation service at the Airport unless and until my company is in possession of a valid and current Ground Transportation Vehicle-for-Hire Company Permit. I also

understand that for any driver that operates under my company's ground transportation vehicles for hire permit that elects to undergo a private background check will result in **ALL** drivers being assessed the terminal security fee of \$2.35 per trip in addition to the current \$1.50 assembly area access fee. Further, I understand that the submission of this application does **not** guarantee that my Company shall receive a Ground Transportation Vehicle-for-Hire Company Permit.
